PURPOSE

BACKGROUND INFORMATION

Savanna Drive is located in the southwest part of Shreveport about 2000' east of Mansfield Rd. on Bert Kouns Industrial Loop.

Mr. Robert Westerman, Assistant City Engineer, has recommended that the additional dedication as shown on the plat be dedicated to the public for public use in the City of Shreveport.

The Metropolitan Planning Commission approved the dedication on August 7, 2013.

The Master Plan makes no specific recommendation regarding the standard practice of street dedication for public use.
