**PURPOSE**

To transfer \$7,020 from the General Fund Improvements and Equipment (Fire Department) as matching funds for a new Fire Grant.

**BACKGROUND INFORMATION**

The Fire Department has been awarded a FY2012 Assistance to Firefighters Grant Program-Fire and Prevention Safety Grant to purchase smoke alarms for installation in homes throughout the City of Shreveport. This ordinance accepts the funds awarded by the Federal Emergency Management Agency (FEMA) and the Department of Homeland Security (DHS). The total grant awarded is \$35,100 and the federal share of \$28,080 requires a city match of \$7,020 which will be appropriated by transfer from the Fire Department Improvements & Equipment Budget within the General Fund.

WHEREAS, the City Council finds it necessary to amend the 2013 General Fund Budget.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Shreveport, in legal session convened, that Ordinance No. 135 of 2012, the 2013 General Fund Budget, is hereby amended as follows:

In Section 2- Appropriations

Fire

Decrease Materials & Supplies by \$7,020  
Increase Transfer to Other Funds by \$7,020

Adjust totals and sub-totals accordingly.

BE IT FURTHER ORDAINED that the remainder of Ordinance No. 135 of 2012 as amended, shall remain unchanged and in full force and effect;

BE IT FURTHER ORDAINED that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications; and to this end, the provisions of this ordinance are hereby declared severable.

BE IT FURTHER ORDAINED that all ordinances or parts thereof in conflict herewith are hereby repealed.
