**BACKGROUND INFORMATION**

Kings Highway I-49 Subdivision is located in the center part of Shreveport at I-49 and Kings Highway intersection.

Mr. Robert Westerman, City Engineer, has recommended that the servitude as shown on the plat be dedicated to the public for public use in the City of Shreveport.

The Metropolitan Planning Commission approved the plat on October 11, 2016.

**BE IT FURTHER RESOLVED** that the original plat reflecting the dedication for a 15 foot wide sanitary sewer servitude, be recorded in the official records of the Clerk of Court for Caddo Parish, Louisiana.

**BE IT FURTHER RESOLVED** that if any provision or item of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications and to this end the provisions of this ordinance are hereby declared severable.

**BE IT FURTHER RESOLVED** that all ordinances or resolutions or parts thereof in conflict herewith are hereby repealed.
