**A RESOLUTION TO SUSPEND PROVISIONS OF CHAPTER 10 AND CHAPTER 106 OF THE CODE OF ORDINANCES RELATIVE TO THE SALE, DISPENSING AND CONSUMPTION OF ALCOHOLIC BEVERAGES DURING SHREVEPORT RAFTERS RESERVES WINTER SEASON SOCCER GAMES AT LOUISIANA STATE UNIVERSITY AT SHREVEPORT (LSU-S) AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.**

**WHEREAS**, the Shreveport Rafters Reserves Soccer Team will play a Winter Season at Louisiana State University in Shreveport (LSU-S) this fall and winter; and

**WHEREAS**, LSU-S has agreed to allow the sale of alcoholic beverages at the games, and local alcohol permit(s) have been requested by the Shreveport Rafters Reserves from the City of Shreveport; and

**WHEREAS**, a Louisiana *State* Special Event Alcohol Permit shall be filed under the Shreveport Rafters name for each of the dates as shown below along with a letter from LSU-S stating that the Shreveport Rafter's has permission from LSU-S to use its property for the events and to sell alcoholic beverages on the premises; and

**WHEREAS**, pursuant to the *State* Special Event Alcohol Permit the Shreveport Rafters shall provide either a copy of a *local* Special Event Alcohol Permit *or* a letter from the local governing authority granting permission to sell or serve alcoholic beverages relative to the event(s); and

**WHEREAS**, a copy of this Resolution shall serve as the City's grant of permission to sell or serve alcoholic beverages relative to the event(s); and

**WHEREAS**, Shreveport Rafters management will also provide any insurance or security as needed by LSU-S or the City of Shreveport; and

**WHEREAS**, the adoption of this resolution would allow the sale, dispensing and consumption and of alcoholic beverages at the below described event(s).

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Shreveport in due, legal and regular session convened that the provisions of Chapter 10 and Chapter 106 of the Code of Ordinances are hereby suspended to the limited extent necessary to allow these events on the following dates and times:

All other provisions of said chapters of the Code of Ordinances shall remain in full force and effect. This suspension shall not apply to the sidewalk or the street(s) unless the street(s) have been closed by proper authority.

A copy of this Resolution shall serve as the City's grant of permission to sell or serve alcoholic beverages relative to the event(s).

**BE IT FURTHER RESOLVED** that if any provision or item of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this resolution which can be given effect without the invalid provisions, items or application, and to this end, the provisions of this resolution are hereby declared severable.

**BE IT FURTHER RESOLVED** that all resolutions or parts thereof in conflict herewith are hereby repealed.
