**Subject:** Monthly Financial Reports for the eight months ended August 31, 2019 and August 31, 2020

Attached are the summary financial reports provided by the Finance Department for the eight months ended August 31, 2019 and August 31, 2020. The first report provides a year-to-date comparison of sales tax collections. The second report provides a year to date comparison of selected General Fund revenues. The third report provides a year-to-date comparison of selected revenues in the enterprise funds. The fourth and fifth reports provide a year to date comparison of General Fund departmental expenditures and expenditures of other selected funds. The fifth report is a more detailed version of the fourth.

In addition to these summary reports, I have included the Calculation of Sales Taxes – 2020 and Logos “Budget Performance Reports” for the General Fund and Enterprise Funds for the eight month periods presented. The reports are produced by the Accounting Division. The other four reports are produced directly from the Logos accounting system, and all reports are included to provide you with more detailed information.

**CITY OF SHREVEPORT  
SALES TAX REVENUES  
2019 and 2020 Monthly and Cumulative Comparison**

Sales tax collections in August, 2020 for the month of July, 2020 were \$10,728,941; and were up by 3% over August 2019 collections for July 2019. With seven months experience, collections are down 1% from 2019 to 2020; however, with the State's economy essentially shut down for the entire month of April and half the month of May for the Covid-19 pandemic, these numbers could have been much worse. The August 2020 numbers represent almost two full months of Phase 2 reopening which continued through August. With schools opening in August and September, and Phase 3 reopening in September, there is hope that back to school and fall seasonal buying may provide several more months of robust sales and sales tax collections.
